2. Financial Update

Steve McClain, Chief Business Officer, shared that Cindy Frantz from EdTec will be presenting the Second Interim Financial Report for GA-Arvin and GA-Shafter. Before Cindy begins her presentation, we wanted to mention that the remaining board meeting dates for this year and the proposed dates for the 2024-2025 school year are included in your board packet. They are listed as a consent item on today's agenda.

Doc Ervin, Chief Executive Officer, further informed the board that the upcoming June 24th meeting will include the LCAP Public Hearing, just like last year's June meeting.

Cindy Frantz began her presentation by sharing that the second interim financials are one of the four mandatory reports required by the authorizers each year. She proceeded to discuss the financial status, noting that due to the transition to the countywide benefit, the one-time grant funds will expire. Consequently, the funds from these grants have been allocated into this fiscal year. Additionally, she mentioned that we can anticipate delayed funding for LCFF and Lottery in FY25. Discussions regarding the Extended Learning Opportunities Program (ELOP), Prop 28, and Title IV funding are ongoing.
